## ORDER:

In the Government order first read above, orders were issued for the implementation of a Scheme to create employment opportunities to 100 educated fisher youth through upgradation of skills in Maritime Education and Nautical Sciences at a cost of Rs.50.00 lakh every year at the rate of Rs.50,000/- per student and also sanctioned a sum of Rs.50.00 lakh for the implementation of the Scheme during 2007-2008. The Director of Fisheries has stated that for the year 2007-2008, the financial assistance was granted only for nine youth for the following two Maritime Diploma courses:-

- i. Diploma in Nautical Sciences
- ii. Diploma in Maritime Engineering

- 2. On considering that only few youth were taking the above two Maritime Diploma Courses and availing financial benefits, with a view to extend the benefits to more members, orders were issued in the Government order second read above including four more Diploma Courses in the scheme in addition to the two Diploma Courses already permitted:
  - i. Deck Cadets One year course leading to B.Sc., (Nautical Science)
  - ii. Two years course of trainee Marine Engineering Course for Diploma Engineers
  - iii. One year course of trainee Marine Engineering Course for Graduate Engineers.
  - iv. Three years course of B.Sc., (Nautical Science)
- 3. In the Government order third, fourth, fifth and sixth read above, orders were issued sanctioning a sum of Rs.50.00 lakh each towards awarding Financial Assistance / Scholarships to 100 educated fisher youth for the years 2012-2013 to 2018-2019 respectively.
- 4. In the letter seventh read above, the Director of Fisheries has requested the Government to sanction a sum of Rs.50.00 lakh, towards awarding financial assistance/ scholarships to fisher youth for the year 2019-2020.
- 5. The Government, after careful examination decided to accept the proposal of the Director of Fisheries at para.4 above and sanction a sum of Rs.50.00 lakh (Rupees fifty lakh only) towards awarding Financial Assistance / Scholarships to the fisher youth for the year 2019-2020.
- 6. The expenditure sanctioned in para-5 above shall be debited to the following Head of Account:-

"2405-00 - Fisheries - 800 Other Expenditure - State's Expenditure - KG Employment Opportunities to Educated Fishermen Youth 312 Scholarships and Stipends - 09 - Others."

7. Necessary additional funds of Rs.50,00,000/- will be provided in Revised Estimate/ Final Modified Appropriation 2020-21. Pending provision of funds in Revised Estimate/ Final Modified Appropriation 2020-21, the Director of Fisheries is authorized to draw and disburse the amount sanctioned in para-5 above. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimate 2020-21. The Director of Fisheries is directed to include this item of expenditure while sending the proposal for Revised Estimate/ Final Modified Appropriation 2020-21 and also send draft explanatory note for inclusion of the expenditure in the Supplementary Estimate to Government in Finance Department without fail.

- 8. The Director of Fisheries is also requested to furnish the Utilization Certificate while sending the pending proposal for the next year.
- 9. This order issues with the concurrence of Finance Department vide its U.O.No.32255/Finance(AHD&F)/2020, dated:05.10.2020 and Additional Sanction Ledger No.645 (Six hundred and Fourty Five).
