Nautical Science and Cadet Shubam, the Student Council Chairman is in the final year course. During the inquiry, it has been revealed that prior to the issue in question; they were all maintaining cordial relationship, besides close acquaintance with each other as well.

However, the Committee did not want to give any room for such incidents to happen in future and hence advised the cadet Shubham Shah that as the Chairman of the Student Council he should always be polite and behave in proper manner with his co-cadets, besides given a warning to him. Both the parties involved in the issue were satisfied with the proceedings conducted and the decision taken and the issue was settled in an amicable and appropriate manner. The Committee authorized the Registrar to send the Report to the Supervisor, Anti Ragging Helpline.
